

Regulations of Jerusalem Dance Center

The Jerusalem Dance Arts Center (hereinafter "the Dance Center") is a registered non-profit association that operates a dance school for children and youth from the Jerusalem area. Our method of study is individual. We devote maximum attention to every student in the studio, and try to help them as much as we can to realize their dreams in the field of dance.

General:

- The school year at the Dance Center begins on the first of September and ends on June 30th of the subsequent year.
- Semester registration: The year is divided to two semesters with independent registrations: The Fall Semester which starts on September 1st. and ends on January 31st. and The Winter Semester starts on February 1st. and ends on June 30th.
- Payment upon registration can be made in cash, credit card, or checks (with credit card backup). Payment will be in full for the entire semester, but can be divided into five installments (except in case of cash payment).
- No class attendance is permitted without the payment arrangement at the beginning of each semester.
- During the summer months we hold summer classes and courses at a separate
- In general, all payments have to be arranged before classes begin.
- Tuition includes all vacations according to the Israeli education system.
- All messages to students during the year are via email. Parents are kindly requested to follow the studio's emails regarding changes in the schedule.

Tuition:

- Tuition fees are listed in the attached table and vary according to the number of weekly hours. Brothers or sisters receive a 10% discount on tuition (of the lower fees).
- In addition to tuition fees, we charge a registration fee of NIS 100 per student.
- Tuition does not include payment for a group uniform, which we order collectively at the beginning of the year, as well as participation fees for the annual show (equivalent to 4-6 tickets).
- Bounced checks incur a fee of 40IS.
- Late payments of 10 days or more incur an extra fee of 5%.

Cancellation policy and refunds

- Under the Consumer Protection Law, a class can be canceled up to 14 days from the date of registration, with a cancellation fee of 5% or 100 NIS (whichever is lower). There is no refund for the registration fee.
- After this time it is not possible to cancel the registration and receive a refund.
- In special cases, credit can be obtained for other classes in the studio.
- Cancelation has to be in writing to the studio mail address, with a confirmed response.
- Those who registered after a month's trial cannot cancel registration as the 14 days are already included in the count of these days.
- There is no refund for absence from classes, except for injury or prolonged sickness with medical clearance.
- Summer courses cannot be refunded after the opening of the course.

Dress Code:

Each group in the studio has its own uniform that we order at the beginning of the year. The students must appear to all classes in the group dress, clean and spotless, with their hair tied in a bun (a ponytail for the pre-ballet and beginners), in ballet shoes, and without any jewelry.

Behavior code:

In general, ballet classes require high discipline from student. The students learn to obey the teacher and perform the exercises as required of them, to treat other students appropriately, and to obey the rules of the studio. These include:

- Arrive in time to the studio, usually 15 minutes before the class begins to dress and warm up.
- Do not eat or drink soft drinks inside the studio.
- Takeoff walking shoes before stepping on the dance floor.
- Keep the studio and dressing room clean.
- Behave in a respectful way to others.
- Do not take pictures of other students.
- A student who violates the rules of conduct in the studio may be expelled from the classes without a monetary compensation.

End of Year Show:

- At the end of each school year, the Center for Dance Arts conducts a recital in front of live audience where our students present dance pieces they learned during the year. Participation in the show is not an automatic right, but depends on a number of conditions:
- The students prepared for the performance and participated in rehearsals as determined by the artistic director.

- The students paid a participation fee (purchase of a minimum of tickets: 4 for preballet and beginners, 5 for intermediates, and 6 for the advanced group).
- Students who did not meet these conditions will not be allowed to appear in the show without any monetary credit.
- We want to emphasize that participation in the show is not mandatory and students who prefer not to perform will participate in all classes but can be excused from the show.

Health Declaration:

I hereby declare that my daughter / son is fit to perform intensive physical activity within the framework of the Jerusalem Dance Center. If there is a medical condition, a medical certificate is required that allows him or her to participate in classes.
